Russian State University of Cinematography named after S.A. Gerasimov (VGIK) represented by its rector Prof. Vladimir Malyshev acting on the basis of the Articles of Association, and NATFA represented by Prof. Dr. St. Ivanov acting on the basis of Articles of Association hereunder also referred to as the Party in the singular and the Parties in plural, aiming at supporting public initiatives in preparing and carrying out international projects and programs in education, culture and art, promoting contacts between educational institutions and disseminating information on education and culture in the \_\_\_\_\_ and Russian Federation, have concluded the present Agreement on the following.

I. SUBJECT OF AGREEMENT

1.1. The subject of the Agreement is the development of the educational, academic and creative links between the Parties.

II. GENERAL PROVISIONS

2.1. The Parties shall work actively towards further mutual cooperation in the following directions:

2.1.1 Exchange of students and teachers aimed at familiarizing with the values of the teaching process, academic research and artistic activity of the partner (the number of the participants and the dates of the visits shall be defined in the course of work);

2.1.2 Exchange of stage performances and films;

2.1.3 Participation in festivals held by the partner school;

2.1.4 Holding mutual cultural events and projects, symposia and workshops;

2.1.5 Exchange of information in the organization of the teaching process, training and methodological materials, periodicals and information on the directions and results of the mutual activities;

2.1.6 Publication of academic articles in the periodicals of both film schools.

### III. TERMS OF COOPERATION

- 3.1. The Parties shall cooperate in the convenient and available forms.
- 3.2. In order to implement specific projects the Parties shall sign supplementary agreements entailing the legal and financial terms, which are an integral part of the present Agreement.

### IV. VALIDITY OF AGREEMENT

- 4.1. The present Agreement enters into force from the date of its signing and is valid until the decision of its termination by one of the Parties.
- 4.2. The notification of the intention to terminate or substantially change the present Agreement shall be forwarded in written form.

### V. FINAL PROVISIONS

- 5.1. The present Agreement is drawn in four equally valid copies, two in Russian and two in English.
